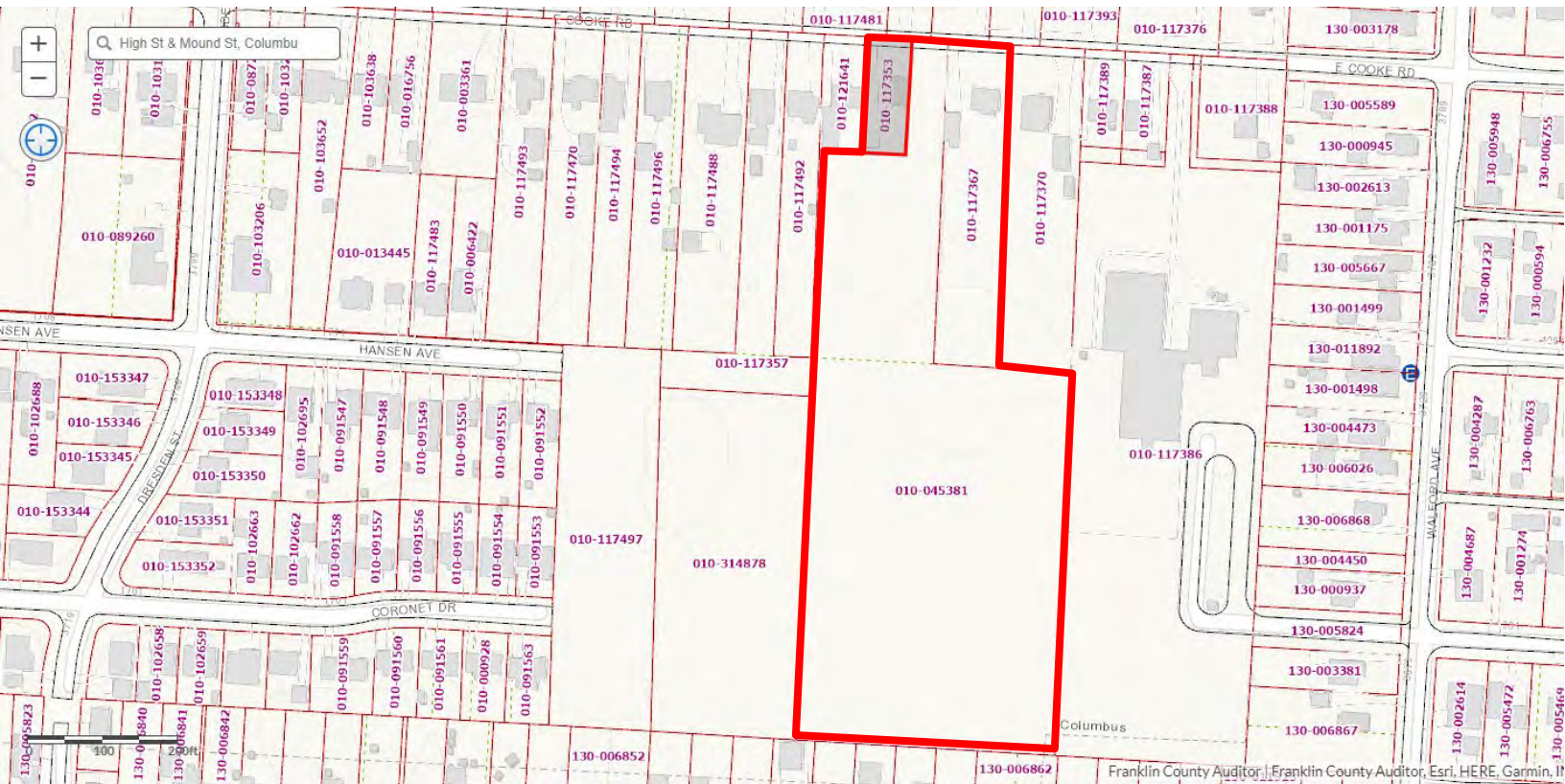
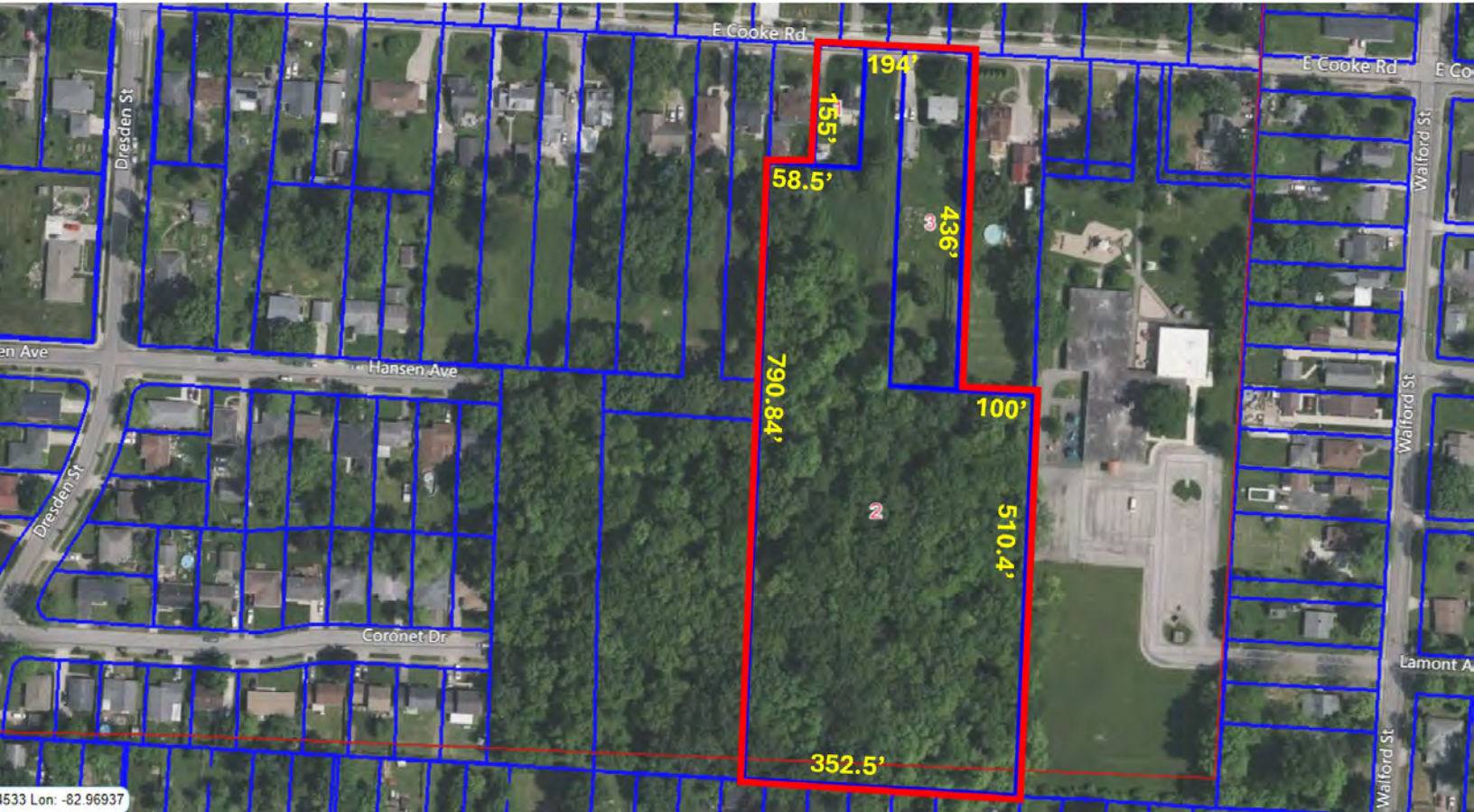
This project will include roadway pavement removal and replacement with the addition of curb and gutter along the entire 1.02-mile corridor. This project includes two 11-foot through lanes, curb and gutter, a ten-foot-wide asphalt shared use path along the north side of the road, and a five-foot wide concrete sidewalk along the south side of the road. The project also includes driveway improvements, storm sewer improvements including stormwater management, street lighting, and new pavement markings and traffic signs. The project will require right-of-way acquisition on a small percentage of parcels and utility relocation along the corridor.

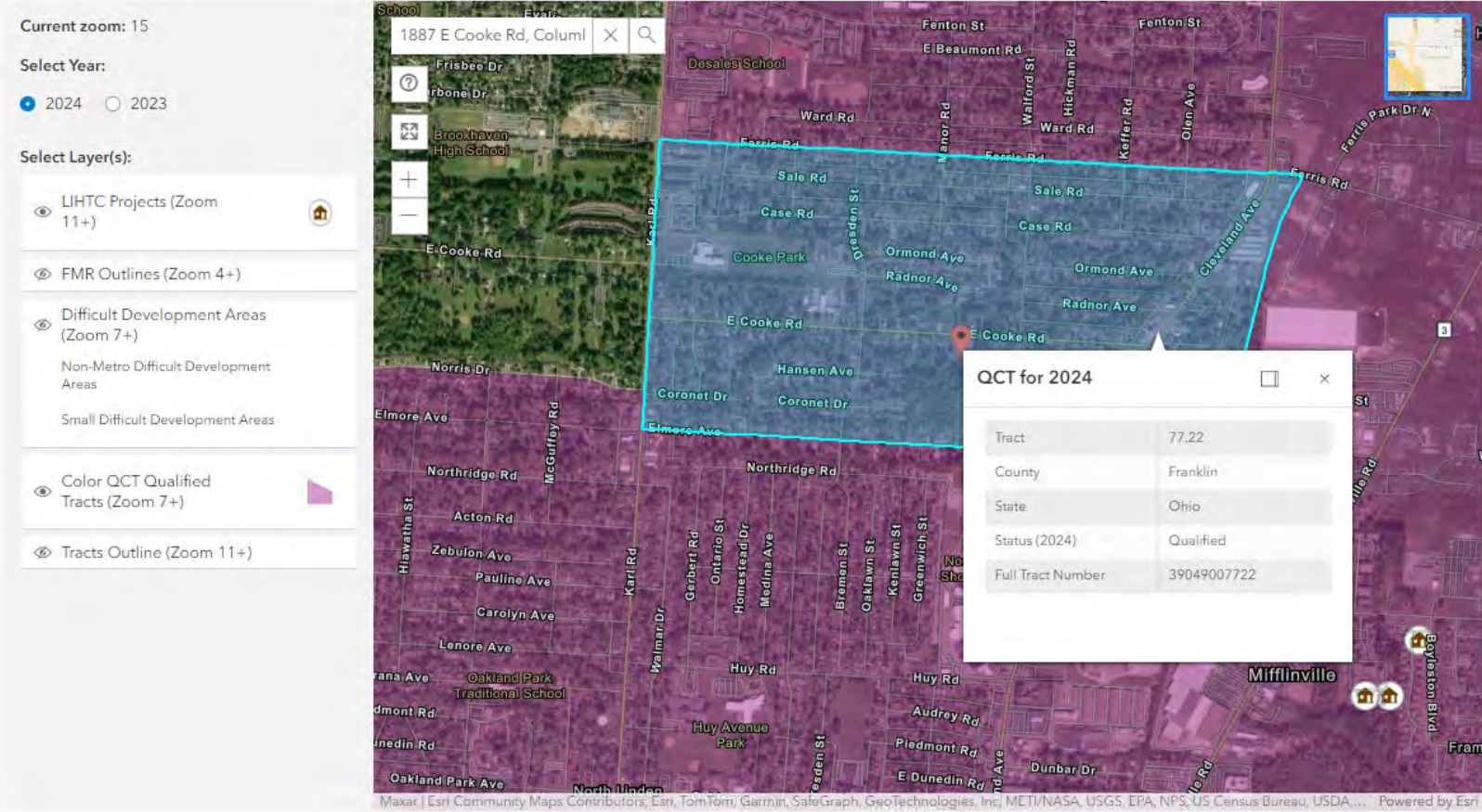
E Cooke Rd Corridor Improvement Project Exhibit

Overview of 2023 and 2024 Small DDAs and QCTs
